





Our Board of Directors of CCPAA-ON currently consists of nine (9) directors, including the President. The Board of Directors appoints the President, who then appoints other members in the Executive Committee.

The Board of Directors has set up a governance committee and an operational oversight committee. The directors' term of office is four years and each director can serve no more than two consecutive terms. Any vacancy occurring in the Board may be filled for the remainder of the term by the directors then in office. The slate of directors shall be approved by the majority of the active voting members of CCPAA-ON at its annual general meeting duly called and held.

The President is elected with a regular term of three (3) years, and can be extended by the Board of Directors. The President nominates the members in the Executive Committee, which is subject to the approval of the Board of Directors. The Executive Committee is responsible for the daily operations and project executions of the CCPAA-ON.





In 2020 and 2021, the M&A landscape witnessed a considerable uptick due to cheaper financing and lower interest rates. Despite the initial downturn, deal volumes are expected to rebound quickly in 2023 as a result of the global economic recovery and disruptions in the financial service industries, such as the collapse of Silicon Valley Bank (SVB), US Operations acquired by First Citizen, and sale of Credit Suisse to UBS.


